Camp Goal: The Northern Colorado Volleyball Officiating Camp is designed for any official who has the desire to improve their current level of officiating through positive, constructive feedback from experienced officials and observers.

Caliber of Play: 150-180 high school teams from eight states participate in four divisions (Elite, top varsity, varsity/solid JV, and JV/incomingfreshmen) at the Northern Colorado Volleyball Team Camp. Many of the teams are state tournament quality teams.

The camp fee and other related cost may be tax deductible.

Format: The camp is held in conjunction with the University of Northern Colorado Team Volleyball Camp. Teams from several states participate in C, junior varsity, varsity and state (elite) level divisions. Through the years well over two hundred officials, including several from Montana and Wyoming, have taken part in the two or three-day camp in which each camp official works in both the First Referee and Second Referee positions while being observed by a current or former state tournament official. The officials are given suggestions for improvement as well as reinforcing those things they do well. On average, each camp official works seven to ten matches over the two or three days. The officials are placed on matches based on their and the teams' skill levels. In other words, newer officials are placed on lower level matches while officials with higher skill and experience officiate the elite division. During each match clinicians may instruct the officials, particularly during time outs and between sets. Feedback is immediate. After each match, the two camp officials and the clinician sit down to debrief the match further.

Colorado Regional Clinic credit will be given for participation at camp!

Classroom sessions: In addition, every camp official and clinician attend classroom sessions that include the new rules. A role play session where different situations are played out by camp officials, clinicians or both, is not only a learning experience but entertaining as well. Topics covered in the classroom or on court include: court presence, mechanics, communication with the officiating crew, game management, ball handling, net play, alignment and various types of protocol. The camp also serves as a place to network and socialize.

Lodging: UNC offers dorm rooms at \$50 per night which **includes** breakfast. All dorm rooms are air conditioned. You may make one check to NCVOC to include both the dorm and camp fee.

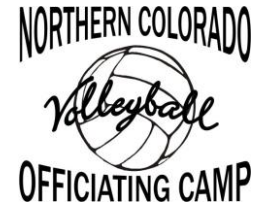
